### END-USER LICENSE AGREEMENT FOR VIQ Solutions SOFTWARE

By breaking the seal on this SOFTWARE PRODUCT, you agree to be bound by the terms of the EULA. If you do not agree to the terms of the EULA, do not break the seal on this SOFTWARE PRODUCT. If the SOFTWARE PRODUCT was purchased by you, you may return it to your place of purchase for a full refund. **For the most current version please contact your Dealer or VIQ Solutions Inc.**
